SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Although the global pandemic created many challenges regarding in-person collaboration, the District worked diligently to engage as many stakeholders as possible in the planning, development and intended implementation of how to best utilize funds for our students and district. Informational conversations and discussions took place during open sessions at monthly Board of Education meetings. Board members, staff and community members were asked to provide input and to share ideas. In addition, stakeholders participated in large group, socially distanced planning sessions in the school's gymnasium in order to identify and prioritize initiatives. Stakeholders present at these meetings included District Administration, Board of Education members, CSE/CPSE Chairperson; School Related Personnel Union Leadership; Lyme Central School Teachers Union Leadership; Dr. Gianfagna (school physician); respresentatives from the Jefferson County Department of Health; members of student leadership. There are currently no tribes or civil rights organizations within our school district. We currently have no English Language Learners or students/families identified as being homeless.

We will continue to engage stakeholders throughout the implementation of the plan through updates given at monthly Board of Education meetings, on our district webpage, through postings on social media platforms (ie: Facebook and ParentSquare), and as noted in published quarterly newsletter articles.

The District's Reopening Plan is being revised, during the summer of 2021, in accordance to the most recent CDC guidance on reopening of schools. To continuously and safely open and operate our schools for in-person learning District staff will continue to follow it's updated reopening plan with fidelity. Social distancing and the use of all appropriate PPE for staff, students and visitors will continue. Funds will be utilized to purchase supplies and equipment necessary for the ongoing and extensive daily cleaning and sanitizing classrooms, buses, common areas and large multi-purpose academic areas throughout the district. In is our expectation that if all mitigation strategies such as frequent deep cleanings of surfaces, floors, high touch areas, etc. will promote health and wellness of students and staff and lesson the likely transmission of the COVID virus. By doing so, we will be more likely to remain open for in-person learning. As necessary, additional staff will be hired to assist with these initiatives in order to address learning loss, maintain academic rigor for students, support awareness and professional growth for staff, parents, community members and students. In addition, staff will utilized to provide extra curricular opportunities for students, address social emotional needs and provide a safe and clean learning environment for all building/school stakeholders.

The district plans to utilize funds to purchase additional student and teacher desks and charis to allow for required social distancing protocols. A floor cleaning machine will be purchased in order to assist with keeping the facilities clean and sanitized as well as to mnimize the risk of virus

Student growth will be monitored and evaluated by consistent academic data analysis, considering various learning targets. Teachers will implement strategies and adjust their instructional practices based on student need using a wide variety of strategies and such instructional tools as, but not limited to, Iready Student Achievement Program, District developed interim assessments, and teacher made screening tools, assessments and observations. Monitoring the social emotional health and needs of students and staff is a district priority. The district will contract with a local agency for extended, additional counseling services in an effort to support this priority.

The Lyme Central School District will hire a Speech Pathologist to addres identified learning loss.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

The Lyme Central School District will hire a full-time Speech-Language Pathologist to provide much needed instructional support to our students. This service provider will focus work with students on instructional strategies to enhance student communication skills (oral and written); social skills (including but not limited to carrying on conversations, matching emotions to faces; communicating in a variety of situations; and so on); improving language skills; articulation; fluency; use of voice, etc.

The Lyme Central School District will operate an after-school program in order to address the academic impact of lost instructional time. The district will hire instructional staff for the after school program. Comprehensive instructional strategies will be used by staff and teachers and support staff will provide much needed supplemental instruction to students who require additional academic suport in order to be successful in their classes. The district will also hire teacher assistants to help monitor students attending the after school program. Bus drivers will also be hired to provide safe transportation home from the after school program.

Additional funds will be utilized as follows:

- A new Reading curriculum will be purchased to provide continuity of instruction for students to address impacts of learning loss which occured as a result of the global pandemic
- · Funds will be used to plan and implement an afterschool enrichment and supplemental program
- Provide staff, students and community members will training and professional development to enhance awareness and the identification of individuals struggling with mental health issues
- · Purchasing instructional technology and PPE equipement and materials as necessary

For the 2021-2022 school year, .275 FTE Academic Support Teacher and for the 2022-2023 School Year, .263 FTE Academic Support Teacher will provide small group instruction in the areas of ELA and Math for students in grades K-6.

For the 2021-2022 and 2022-2023 school years, a 1.0 FTE Health Teacher will provide social emotional support as well as Health Education to students in grades K-12.

We are utilizing these funds to support our need of retaining current, existing staff members.

7. The District will continue to follow the revised Reopening Plan for the upcoming school year. Student data, including regular in-person attendance, will be monitored and analyzed regularly during planned faculty, curriculum and grade level meetings. Student referrals and class/course failure lists will be monitored by instructional staff and administration. An afterschool program will be developed to address learning loss for all students including students from low-income familes, students of color, children with disabilitiles, students experiencing homelessness, children in foster care and migratory students. While we currently have no ELL students, we are prepared to serve any who enter our district. Instructional support staff will provide one on one or small group interventions in order to address individualized student needs. Attendance and participation in the afterschool program will be mandatory for any student who is in need of additional academic intervention/support, passed on teacher or parent referrals, etc.
